TAX COLLECTION: Payments accepted by USPS/mail only. Please issue check or money order to *Rhonda Seidl* *Town of Hammel Treasurer* for the exact amount of your payment due. (Please include phone number on the check). **No receipts will be sent this year unless a self-addressed stamped 10" envelope is included. Receipts can also be printed from the Taylor County website www.co.taylor.wi.us for your convenience.**

USPS POLICY CHANGE: Due to the change in policy nationwide effective Aug 2, postmarks are not being affixed until they reach the regional sorting centers. That means your postmark could be several days after you put it in your mailbox. Federal & State law defines timely payments based off the post mark, so we encourage you to mail your payment early to avoid becoming delinquent.

RECYCLING: 1st and 3rd Saturdays of each month 7:30 a.m. to 11:30 a.m. Please remember that if you take in your scrap metal or aluminum for cash to submit your receipt or a copy to the recycle attendant or Brad Clarkson so that the township can receive credit for pounds recycled.

GARBAGE COLLECTION: 1st and 3rd Saturdays of each month 7:30 a.m. to 11:30 a.m. Garbage bags are available individually for \$3.00 each from the attendant. These are the only bags that are to be used for garbage collection. Cash payment only for bags.

SAND/SALT MIX: This year the town will again offer sand/salt mix to residents at \$1.00 per five-gallon pail. Bring your own pail. Available self-serve at the town hall.
